This form should be used to submit a data subject request under the provisions of the Personal Data Protection Law (**PDPL**) in the Kingdom of Saudi Arabia.

The Personal Data required by this form is necessary to enable **FAB CAPITAL** ("FABC", "us" or "our") to process your Data Subject Request. The information you supply will only be used for the purposes of identifying the Personal Data you are requesting and for responding to your request, in accordance with the PDPL. It may be shared with our legal and administrative teams, and it will be stored securely until the relevant procedures are completed.

In certain circumstances, where disclosure of part or all of the information you have requested would adversely affect the rights and freedoms of others, we may not be able to disclose the information to you, in which case you will be informed promptly and given full reasons for that decision. Please further note that information covered by a legal professional privilege, or any other confidentiality obligations cannot be disclosed.

Other types of Data Subject Requests are subject to certain conditions and exceptions. We will advise you in writing if we are unable to give effect to your request under the Data Subject Request or if we believe that your Data Subject Request fails to meet the requirements of the PDPL in whole or in part.



In most circumstances, **FABC** will provide you with a copy of the information requested free of charge. However, **FABC** may be permitted to charge a reasonable fee if a Data Subject Request is repetitive or manifestly unfounded or excessive. **FABC** also may charge a reasonable fee to comply with Data Subject Requests for further copies of the same information. The fee will be based on the administrative cost of providing the information.
